

The American National Socialist State Laws on Citizenship and Race: November 21, 2010



Proposed American National Socialist State Citizenship Law

The National Socialist American Labor Party Congress HAS ADOPTED by unanimous vote the following policy proposal.

ARTICLE 1.

(1) A subject of the state is one who belongs to the protective union of the American National Socialist Nation, and who, therefore, has specific obligations to the American National Community.

(2) The status of subject is to be acquired in accordance with the provisions of the American National Community and the State Citizenship Law. Citizenship by mere birth is hereby abolished.

(3) Non Aryan immigration is abolished in the interest of the National Community, all illegal immigrants of Non Aryan ethnicity are hereby declared enemy aliens and are to be deported upon apprehension, including any offspring born in the United States, such offspring are considered fruits of criminal activity.

ARTICLE 2.

(1) A citizen of the American National Socialist Nation may be only one who is of Aryan or kindred blood, and who, through his/her behavior, shows that he/she is both desirous and personally fit to serve the American National Community and the American National Socialist State.

(2) The right to citizenship is obtained by the grant of American National Socialist State citizenship documents.

(3) Only a citizen of the American National Socialist State may enjoy full political rights in consonance with the provisions of the laws.

ARTICLE 3.

(1) Until further provisions concerning citizenship papers, all subjects of Aryan or kindred blood who possessed the right to vote in the American National Socialist State elections when the Citizenship Law came into effect, shall, for the present, possess the rights of American National Socialist State citizens.

(2) The American National Socialist State may revoke citizenship. Citizenship as a matter of right is hereby abolished.

(3) No citizen of the American National Socialist Nation may hold, enjoy, hold, retain, or seek so called "Dual Citizenship" with any other Nation, State, or group that is declared a State in and of itself absent geographic borders.

ARTICLE 4.

(1) The provisions of Article 1 through 3 shall apply also to subjects who are of mixed Jewish, Negroid, or Asian blood.

(2) An individual of mixed Jewish, Negroid, or Asian blood is one who is descended from one or two grandparents who, racially, were full Jews, Negroes, or Asians insofar that he is not a Jew, Negro, or Asian according to Section 2 of Article 7. Full-blooded Jewish, Negro, or Asian grandparents are those who belonged to the Jewish religious community, possess Negroid features and/or bloodlines, possess Asiatic features and/or bloodlines, or any mixture of these racial characteristics as in the American Hispanic/Indian peoples.

ARTICLE 5

Only citizens of the American National Socialist State, as bearers of full political rights, can exercise the right of voting in political matters, and have the right to hold public office. The American National Socialist State can make exceptions during the transition period on the matter of holding public office. The measures do not apply to matters concerning religious organizations, which are prohibited from using religious doctrine as a vehicle for political activity contrary to the interests of the American National Socialist Nation. No non citizen may participate in, contribute financially or conduct any activities in the influence of political activities of the American National Socialist Nation.

ARTICLE 6

(1) A Jew, Negro, Asian, or mixed race individual cannot be a citizen of the American National Socialist State. He/she cannot exercise the right to vote; he cannot hold public office.

(2) Jewish, Negro, Asian or mixed race officials will be retired as soon as possible. In the event that such officials served in active duty military combat in any branch of the military they shall receive as pension, until they reach the age limit, the full salary last received, on the basis of which their pension would have been computed. They shall not, however, be promoted according to their seniority in rank. When they reach the age limit, their pension will be computed again, according to the salary last received on which their pension was to be calculated.

(3) These provisions do not concern the affairs of religious organizations. Provisions as stated to religious organizations in Article 5 apply.

(4) The conditions regarding service of Jewish, Negro, Asian or mixed race teachers in public schools remains unchanged until the promulgation of new laws on the school system.

ARTICLE 7

(1) A Jew, Negro, or Asiatic is an individual who is descended from at least three grandparents who were, racially, full Jews, Negroes, or Asiatics. The mixed race American Hispanics are identified like – and have Hispanic grandparents....

(2) A Jew is also an individual who is descended from two full-Jewish grandparents if:

(a) he was a member of the Jewish religious community when this law was issued, or joined the community later;

(b) when the law was issued, he was married to a person who was a Jew, or was subsequently married to a Jew;

(c) he is the issue from a marriage with a Jew, in the sense of Section I, which was contracted after the coming into effect of the Law for the Protection of American Aryan Blood and Honor of November 21, 2010;

(d) he is the issue of an extramarital relationship with a Jew, in the sense of Section I, and was born out of wedlock after January 1, 2011.

ARTICLE 8

(1) Insofar as there are, in the laws of the American National Socialist Nation or in the decrees of the American National Socialist government and its affiliates, certain requirements for the purity of American Aryan blood which extend beyond Article 5, the same remain untouched....
